| <p><i>Note: Incidents with a case number that start with “CSA #-year” involve information received from the Director of Student Affairs, the Office of Institutional Equity, or other University Administrators, who are defined by federal law as “Campus Security Authorities (CSA’s).” These administrators share non-identifying information, with Corporate Security that is provided by the victim. In these incidents, the crime was reported directly to that CSA and not to Corporate Security, therefore, it is not always possible to provide information regarding the five areas typically covered in the Crime Log, i.e., Nature/Classification (Crime), Date/Time Reported, Date/Time Occurred, General Location and Disposition.
